A. INTRODUCTION TO THE REQUEST FOR PROPOSAL (RFP)

1. Introduction

- 1.1. The Export Credit Insurance Corporation of South Africa (SOC) Limited (ECIC or Corporation)¹ is a self-sustained state-owned entity listed under Schedule 3B of the Public Finance Management Act 1 of 1999 (as amended) and established in terms of the Export Credit and Foreign Investments Insurance Act 78 of 1957 (as amended).
- 1.2. The mandate of ECIC is to facilitate and encourage South African export trade, by underwriting export credit loans and investments outside the country, to enable South African contractors to win capital goods and services contracts in countries outside South Africa. ECIC is a registered Financial Service Provider and is regulated by the Financial Sector Conduct Authority and Prudential Authority (FSP No: 30656). Currently exempted in terms of FAIS Notice 78 of 2019.

2. Background

- 2.1. ECIC seeks to appoint a qualified legal firm to provide specialised legal advisory services for the establishment of a South African Export-Import (Exim) Bank. The appointed bidder will be appointed to render legal services on an ongoing basis for an initial period of 2 (two) years, or until the SA Exim Bank is established.
- 2.2. The appointed legal firm will provide comprehensive legal guidance on the formation, corporate structure, governance framework, regulatory compliance, statutory drafting, and overall legal architecture of the new institution. This partnership is essential to ensure that the establishment of the SA Exim Bank is executed in accordance with South African law, applicable financial-sector regulations, and global best practice.

3. Purpose

- 3.1. The purpose of this Request for Proposal (RFP) is to appoint legal partner with the technical capability, sectoral expertise, and regulatory insight required to support ECIC and government stakeholders in designing, structuring, and establishing a compliant, sustainable, and internationally aligned Exim Bank.

4. Procurement Regulations

- 4.1. This bid is subject to the Preferential Procurement Policy Framework Act No. 5 of 2000 and the Preferential Procurement Regulations, 2022, the General Conditions of Contract (GCC) and, if applicable, any other special conditions of contract. Where, however, the special conditions of contract conflict with the general conditions of contract, the special conditions of contract prevail.

B. TERMS OF REFERENCE

5. Scope of services

5.1. The appointed bidder will be required to provide the following services:

5.1.1. Review of the Legal and Regulatory Framework

5.1.1.1. Review and analyse the current South African legislative and regulatory environment (including supervision by the Prudential Authority and Financial Services Conduct Authority) applicable to the establishment of an SA Exim Bank (e.g. Public Finance Management Act (Act No. 1 of 1999, as amended), Companies Act (Act No. 71 of 2008, as amended), Banks Act (Act No. 94 of 1990, as amended), Financial Sector Regulation Act (Act No. 9 of 2017, as amended), Public Service Act (Act No. 103 of 1994, as amended), Insurance Act (Act No. 18 of 2017, as amended), etc.), including conducting benchmarking exercise of other Exim Banks or ECAs with financing window to establish and recommend an appropriate legislative and regulatory framework for the SA Exim Bank.

5.1.1.2. Review the draft legislation of the SA Exim Bank and an identify any suitable gaps in term of product offering and proposed regulatory framework and identify any gaps and propose appropriate regulatory frameworks or amendments required and suitable for the establishment and operationalise the SA Exim Bank.

5.1.1.3. Assist in drafting and tabling briefing notes and memorandum to different stakeholders including the Minister of the dtic, Cabinet and relevant Parliamentary Committees and Parliament and addressing legal issues raised that need to be incorporated in the proposed SA Exim Bank legislation.

5.1.1.4. Attending engagements with different stakeholders such as the Prudential Authority, Financial Services Conduct Authority, South African Reserve Bank, National Treasury, etc., in dealing with material issues in the proposed SA Exim Bank and as part of soliciting inputs and buy-in from the different stakeholders.

5.1.2. Institutional Form and Corporate Structure

5.1.2.1. The SA Exim Bank needs to operate as policy instrument of RSA Government which will focus on building export trade capacity by provide funding to both export and import transactions, supporting (Small, Medium and Micro Enterprises) (“SMMEs”) by providing capacity building, institutional support and financial assistance in the form of grant funding, loans and equity and trade financing instruments in assisting exporters, SMMEs involved in export and import trade and supporting participation in an inclusive economy. As the envisaged structure in capitalising the SA Exim Bank, will include both the RSA Government and private entities as shareholders in the SA Exim Bank.

Terms of Reference

- 5.1.2.2. The shareholding split between the RSA Government and private entities (which will include some of the (Development Finance Institutions (“DFIs”) and institutional investors) would be key and several options could be considered such as 50/50, 60/40:70/30 or 80/20. In all of these instances, the RSA Government should retain majority shareholding to ensure that the SA Exim Bank continues to operate as a policy institution that implements RSA Government policies, such as industrial policy, supporting SMMEs, building an inclusive and sustainable economy.
- 5.1.2.3. Assist in determining a suitable corporate structure that considers a combination of both RSA Government and private shareholding and recommend the most suitable corporate and ownership structure for the SA Exim Bank (e.g., SOC Ltd, statutory entity, subsidiary, hybrid model).
- 5.1.2.4. Advise on capitalisation structures, governance frameworks, and drafting of shareholder agreements and Memorandum of Incorporation and other relevant constitutional documents.
- 5.1.2.5. Advise and deal with the incorporation of the SA Exim Bank in line with its establishing legislation and in compliance with the Companies Act and PFMA.

6. Knowledge and expertise required

6.1. Bidders must demonstrate proven expertise in the following domains:

6.1.1. Financial sector and banking law

- 6.1.1.1. Extensive experience advising on the establishment, regulation, and governance of banks, DFIs, or financial institutions.
- 6.1.1.2. Deep knowledge of the Banks Act, Financial Sector Regulation Act, SARB/Prudential Authority regulatory requirements, and financial-sector compliance norms.

6.1.2. Public-Sector and State-Owned Entity Law

- 6.1.2.1. Strong understanding of the PFMA, Companies Act, SOC governance frameworks, and public-sector legal requirements.
- 6.1.2.2. Experience advising national government departments, public entities, or DFIs on institutional set-up or restructuring.

6.1.3. Legislative Drafting and Regulatory Reform

- 6.1.3.1. Demonstrated capability in drafting primary and secondary legislation.

6.1.3.2. Experience supporting government processes involving Cabinet, Parliament, or regulatory-impact assessments.

6.1.4. **International Trade and Export Finance Law**

6.1.4.1. Expertise in international trade law, sovereign guarantees, export credit insurance, project finance, and cross-border financing structures.

6.1.4.2. Familiarity with OECD Arrangement on Officially Supported Export Credits, WTO rules, and Berne Union standards.

6.1.5. **Development Finance and DFI Structuring**

6.1.5.1. Practical experience advising on the creation or transformation of development finance institutions or similar government-backed credit entities.

6.1.6. **Project and Transactional Advisory**

6.1.6.1. Proven ability to manage multi-stakeholder projects and deliver complex, multi-phase legal advisory services.

6.1.6.2. Strong due-diligence, analytical, and drafting skills.

6.2. **Team Qualifications**

6.2.1. The bidding firm must provide:

6.2.1.1. Senior attorneys with at least 10 years in banking/financial/regulatory law.

6.2.1.2. Specialists in legislative drafting and public law.

6.2.1.3. Experts in trade law, export finance, or DFI structuring.

6.2.1.4. A multidisciplinary team able to engage with government, regulators, and financial-sector experts.

7. **Duration of contract**

7.1. The appointed bidder will be appointed to render legal services on an ongoing basis for an initial period of 2 (two) years, or until the SA Exim Bank is established.

8. **Confidentiality**

8.1. It will be expected that the service provider signs a confidentiality undertaking as part of the service level agreement.

9. Mandatory documents

9.1. Bidders must submit the following mandatory documents:

9.1.1. A company profile and area of expertise;

9.1.2. Curriculum Vitae (“CV”) of the Key Personnel, including (i.e. Senior Counsel, associates and professional assistants) (together with certified copies of qualifications), containing the following:

9.1.2.1. Areas of expertise highlighted under paragraph 6 above;

9.1.2.2. Years of experience in the identified area of expertise;

9.1.2.3. The Key Personnel must be a Senior Counsel with more 10 years as an admitted Advocate and experience in the identified areas of expertise as highlighted in paragraph 6 above. in the identified area of specialisation; and

9.1.2.4. An admitted Advocate, who is in good standing with the Law Society of South Africa and Legal Practice Council.

9.1.3. Certified proof of admission certificate for each of the Key Personnel; and

9.1.4. A certified copy of the Fidelity Fund Certificate.

NB: Bidders who fail to submit any of the mandatory documents will automatically be disqualified.

10. Due diligence/site inspection

10.1. At the ECIC’s discretion, due diligence and/or site inspection may be conducted on the identified bidder. ECIC will visit the identified bidders’ premises or the bidder’s client (with permission from the bidder) to verify information as contained in their respective bid documents.

10.2. Where applicable, the ECIC will issue criteria for the due diligence review or site inspection beforehand to the applicable bidder(s). Should it be discovered during a due diligence visit or site inspection that the information submitted by the identified bidder is inconsistent with what is on their current premises of business, ECIC reserves the right to disqualify such bidder.

10.3. ECIC may identify another bidder using the next highest points obtained in the evaluation phase, as stipulated in paragraph 11.1.3, taking into consideration the process followed under paragraphs 10.1 and 10.2.

11. Bid evaluation

11.1. The proposals will be evaluated in phases as highlighted below and detailed in paragraphs 11.1.1 to 16 of this document:

11.1.1. Phase One: Compliance

In this evaluation stage, bidders are expected to submit proposals that are in line with the requirements of this bid in all material respects. If the proposal submitted is not in line with the requirements of this bid, the proposal will be considered an unacceptable bid and will be disqualified from further evaluation.

11.1.2. Phase Two: Functional evaluation (Desktop evaluation)

In this evaluation phase, refer to paragraph 12 for detailed information, bidders are expected to obtain a minimum of 80 out of 100 points to proceed to the next evaluation stage. Failure to obtain the prescribed minimum points will result in the proposal being considered an unacceptable bid and disqualified from further evaluation.

11.1.3. Phase Three: Preference point system

The 80/20 preference point system shall apply to this phase, where 80 points represent the maximum obtainable points for the lowest acceptable price, and 20 points represent the maximum obtainable points for Specific Goals. Points will be awarded to a bidder for attaining the Specific Goals under the table as listed in the bid documentation (refer to paragraph 13, read together with the table on page 32 (paragraph 4.1).

11.1.4. Phase Four: Objective criteria

ECIC will apply objective criteria as detailed in paragraph 15.

12. Evaluation Phase Two: Functional

12.1. The proposal submitted by the bidder will be evaluated by the ECIC based on the following criteria and will be rated as the factor score over 5 multiplied by the applicable points:

Factor scores: 0=Poor, 1=Below average, 2=Average, 3=Good, 4=Very Good, 5=Excellent

12.2. Total points achieved under this evaluation criterion will be rounded to the nearest two decimal places.

12.3. Bidders are expected to obtain a minimum of 80 out of 100 points to proceed to the next evaluation stage of the evaluation. Failure to obtain the prescribed minimum points will automatically disqualify the bid offer from proceeding to the next evaluation phase.

13. Evaluation Phase Three: Preference point system

13.1. The formula below will be used to calculate the lowest acceptable bid price:

$$P_s = 80 \left(1 - \frac{P_t - P_{min}}{P_{min}} \right)$$

Where

P_s = Points scored for price of tender under consideration;

P_t = Comparative price of bid or offer under consideration; and

P_{min} = Price of the lowest acceptable tender.

13.2. Depending on the bidder's level of Specific Goals, a maximum of 20 Specific Goals points may be awarded to a bidder. The points scored by a bidder for Specific Goals will be added to the points allocated for price.

13.3. The table below reflects the number of points to be allocated to a bidder for Specific Goals:

14. Document(s) required to substantiate claims for Specific Goals

14.1. For this bid, bidders are requested to provide the following documents in substantiation for their claim of Specific Goals in line with the 2022 Preferential Procurement Regulations:

14.2. Any bid received from a bidder who did not provide the document requested in this paragraph 14 and do not indicate the number of Specific Goals they are claiming for in the SBD6.1 Form, **in the table on page 32 (paragraph 4.1)** shall be awarded zero points for Specific Goals (i.e. both the document required to substantiate the Specific Goals Claimed and the SBD6.1 must be submitted with the response to this bid).

14.3. Points for Specific Goals will be allocated as indicated in paragraph 13 of this RFP and in the SBD 6.1 Form. Bidders are required to indicate how they claim points for each preference point on the SBD6.1 Form, **in the table on page 32 (paragraph 4.1)**. In the event that a bidder does not indicate the preference points they are claiming, the bidder will be awarded zero (0) points for Specific Goals.

15. Phase Four: Objective criteria

15.1. In this evaluation stage, ECIC will check if the bidder has a person who meets the following criteria in awarding the bid:

15.1.1. The bidder has a significant shareholder or owner (or equivalent) (directly or indirectly) who is classified or can be classified as a Prominent Influential Person (PIP) in accordance with the Financial Intelligence Centre Act, 38 of 2001 (FICA).

15.1.2. The bidder has a shareholder or member or owner or director (or equivalent) who has questionable integrity status.

15.1.3. The bidder has a director or equivalent who is classified or can be classified as a PIP in accordance with FICA.

Should the outcome of further due diligence not be satisfactory to ECIC, or if such a person(s) poses an unacceptable high risk reputation and/or integrity of the person(s) be questionable, ECIC reserves the right not to award the bid to that bidder. This process may be repeated for the next bidder if so required.

18. Timeline of the bid process

- 18.1. The period of validity of the tender and the withdrawal of offers, after the closing date and time, is 185 days, expiring on 27 November 2026. If there is a need to extend the bid validity period, ECIC will request, in writing, permission to extend the validity period from all bidders before the expiry of the current validity period.
- 18.2. After the due date for response from bidders on the request to extend the validity period, ECIC will assume that all bidders have agreed to the request to extend and continue evaluating all bids received at the closing date and time as received on the closing date and time. Any award will be on the quoted bid amount as indicated in the proposal as at the closing date and time of the bid. If a bidder does not agree to extend the validity period on the original terms (as at the closing date of the bid), ECIC will stop evaluating the proposal received from such bidder.
